## **Junior Showmanship –**

DOG MUST BE OWNED BY JUNIOR OR RELATIVE

**Novice Junior** – at least 8 and under 12 years of age who has not won 3 firsts in novice at licensed or member show.

**Novice Intermediate:** At least 12 and under 15 years of age who has not won 3 firsts in novice at licensed or member show.

**Novice Senior:** at least 15 and under 18 years of age who has not won 3 firsts in novice at licensed or member show.

**Open Junior:** at least 8 and under 12 years of age who has not won 3 firsts in novice at licensed or member show.

**Open Intermediate:** at least 12 and under 15 years of age who has not won 3 firsts in novice at licensed or member show.

**Open Senior:** at least 15 and under 18 years of age who has not won 3 firsts in novice at licensed or member show.
