The meeting was called to order at 6:30 PM by President Marilyn Casiano. Dawn Fennewald made a motion to accept the January 2018 minutes as printed in the Newsletter, Stephanie Clark 2nd and the motion carried.

President, Marilyn Casiano, stated that there are erroneous rumors circulating stating that Prescott and Kachina are loosing, or have lost their show site. These rumors are totally false, the clubs have always passed the government regulations and inspections needed to maintain the site and will continue to do so in the future as well.
