1. Go to the SignUp Genius page listed below to reserve a time slot for the test(s) you want to complete at the show before 5:00PM Wednesday 25 January 2023. There are two sign-up pages – one for the ATT and one for the CGC/CGCA/TK tests. Be sure you sign up for the correct tests!
2. Bring the required paperwork listed below for the test(s) you want to complete to the secretary's table located near the testing ring at least 20 minutes prior to your reserved time slot.
3. Be ringside and ready to test when your time comes up, have fun with your dog, and (hopefully) earn a new title (or two or three) for your dog!
4. Payments and reservations must be made on line through the SignUp Genius website, day of show entries will not be accepted

## IMPORTANT EXHIBITOR INFORMATION REGARDING ATT ENTRIES

- Only ATT entries on an Official AKC entry form will be accepted. A testing slot **MUST** be reserved prior to 5:00PM MST Wednesday 25 January 2023 **AND** the official entry form and Breed Temperament form turned in at the secretary's table at the testing site at least twenty minutes prior to the reserved time slot in order for a dog to be tested. Time slots may be reserved at <https://signupgenius.com/go/10C0E44AEA92BA0F9CE9-kachina> beginning 8:00AM MST Sunday 1 January 2023. Any reservation made before that time will be removed and the reservation forfeited.
  - Incomplete entries or forms without signature or the "Breed Temperament Form" will not be accepted. The AKC "Your Breed's Temperament" form must be included with the Official ATT Entry Form. The "Your Breed Temperament" form is available at: [www.akc.org/wp-content/uploads/2020/02/Your-Breeds-Temperament-Final-022020.pdf](http://www.akc.org/wp-content/uploads/2020/02/Your-Breeds-Temperament-Final-022020.pdf)
  - Information about your breed's temperament can be found in your breed's AKC breed standard at [www.akc.org](http://www.akc.org) or in the Breed Temperament Guide at <https://s3.amazonaws.com/cdn-origin-etr.akc.org/wp-content/uploads/2019/08/18080311/breed-temperament-guide-akc-fss-Feb2022.pdf>.
  - Official entry forms and Breed Temperament forms may be turned in beginning at 8:00AM Saturday 28 Jan 2023 and 9:00AM Sunday 29 January 2023 at the ATT secretary's table next to the ATT testing ring on the showgrounds.
  - Signs will be posted indicating the location of the testing ring.
- 
- Dogs that are at least 1 year of age are eligible to take the ATT and must either be AKC or FSS registered, listed with Canine Partners or have a Purebred Alternative Listing number.
  - Dogs that are spayed or neutered may participate.
  - Dogs must be able to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), in order to be eligible to earn an ATT title. Dogs with disabilities such as those that are blind, deaf, or have three legs are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that, it is unable to complete whole categories of the test (i.e. - hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title.
  - Entry fee will not be refunded in the event that a dog is absent at the scheduled time slot, disqualified, excused by the Judge, or barred from completion by the ATT Committee.
  - Dogs may not repeat test items in these categories: Social, Auditory, Visual and Unexpected Stimulus. Dogs may attempt test items a total of 3 times for the Tactile and Proprioceptive categories. Scores are adjusted accordingly when test items are repeated.
  - If a dog passes the ATT on two occasions, under two different evaluators, the owner may apply for the AKC Temperament Test (ATT) suffix title by going online; [www.akc.org/akctemptest](http://www.akc.org/akctemptest) and submitting the ATT title application along with the Evaluator Score Sheets (one from each of the two required tests) and the required title application fee. Upon verification, the ATT title will be applied to the dog's record and will appear on the dog's AKC title record. The title certificate will be mailed to the dog's primary owner of record.
  - If because of riots, civil disturbances, or other acts beyond the control of the Kachina Kennel Club it is impossible to open or complete the show, no refund of the entry fee will be made. It is the responsibility of the person submitting the entry form to ensure accuracy of the data on the entry form.
  - Dogs not present at the scheduled sign-up time slot will be considered absent.
  - Dogs not required for further testing are free to leave the testing grounds.
  - A ribbon will be awarded to each dog passing an AKC Temperament Test
  - The Kachina Kennel Club offers a New Title Ribbon for dogs completing an ATT title.

## IMPORTANT EXHIBITOR INFORMATION REGARDING CGC, CGCA, and TK ENTRIES

- A testing slot **MUST** be reserved prior to 5:00PM MST Wednesday 25 January 2023 AND Trick Dog checklist OR CGC/CGCA form turned in at the secretary's table at the testing site at least twenty minutes prior to the reserved time slot in order for a dog to be tested. Kachina KC will provide the three-part carbon CGC/CGCA forms for handlers to complete at the secretary's table near the testing ring. Time slots may be reserved at <https://www.signupgenius.com/go/10C0E44AEA92BA0F9CE9-kachina1> beginning 8:00AM MST Sunday 1 January 2023. Any reservation made prior to that time will be removed and the reservation forfeited.
- Incomplete entries or forms without signature or the Trick Dog checklist will not be accepted. The CGC/CGCA form available from the secretary **MUST** be completed prior to entering the ring to test.
- Official entry forms and Trick Dog checklist and CGC/CGCA forms may be turned in beginning at 8:00AM Saturday 28 January 2023 and 9:00AM Sunday 29 January 2023 at the secretary's table next to the testing ring on the show grounds. Signs will be posted indicating the location of the testing ring.
- If a dog passes the CGC, CGCA, or any of the TK tests, the owner may apply for the corresponding title online [www.akc.org](http://www.akc.org) and submitting the corresponding title application along with the Evaluator Score Sheet and the required title application fee. Upon verification, the title will be applied to the dog's record and will appear on the dog's AKC title record. The title certificate will be mailed to the dog's primary owner of record.
- If because of riots, civil disturbances, or other acts beyond the control of the Kachina Kennel Club it is impossible to open or complete the show, no refund of the entry fee will be made. It is the responsibility of the person submitting the entry form to ensure accuracy of the data on the entry form.
- Dogs not present at the scheduled sign-up time slot will be considered absent.
- Dogs not required for further testing are free to leave the testing grounds.
- A ribbon will be awarded to each dog passing an AKC CGC, CGCA, or TK test.
- The Kachina Kennel Club offers a New Title Ribbon for dogs completing a CGC, CGCA, or TK title.

Temperament tests are open to all dogs at least 12 months of age individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, or individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

### **AKC Rules regarding the code conduct & Sportsmanship will apply**

Persons exhibiting conduct detrimental to the AKC, dogs or persons will be asked to leave the testing site by the event committee, maybe disciplines by AKC, and the entry fees will not be refunded.

No entry fees will be refunded if the event cannot be started or completed by reason o riots, civil disturbances, extreme and/or dangerous weather conditions, and acts of God, public emergency, act of public enemy, strikes or other causes beyond the control of the club.

The Kachina Kennel Club will be following all Federal, State, Local and AKC suggested Guidelines to keep volunteers and testing participants safe.

#### **5 TRICK DOG TITLES:**

##### **Novice Trick Dog (TKN)**

The dog performs 10 skills from the Novice list. (see link to “Application” below for lists of skills). If a dog has a Canine Good Citizen (CGC) certificate or title on record at AKC, it can do 5 Novice tricks (CGC + 5) to earn the Novice title.

##### **Intermediate Trick Dog (TKI)**

The dog must have the Novice title, plus perform 10 Intermediate tricks.

##### **Advanced Trick Dog (TKA)**

The dog must have the Intermediate title, plus perform 10 tricks from the Advanced list.

##### **Trick Dog Performer (TKP)**

In this title, handlers perform a short routine with at least 10 tricks previously learned.

##### **Trick Dog Elite Performer (TKE)**

Testing of this truly elite trick dog level requires the dog to perform 10 tricks with at least 5 props and there must be a story.

## Testing Information

- Dogs may **NOT** wear prong collars, e-collars, head collars or harnesses that restrict movement for tests.
- Dogs may wear slip collars on a dead ring, buckle collars, martingales or body harnesses.
- The use of food is not permitted. The use of clickers is not permitted. The use of toys as rewards is not permitted. You may talk to and encourage your dog, but not excessively. No verbal or leash corrections.

No luring of dog (no use of imaginary food).

- Entered dogs will not be permitted into the testing area until their testing time. There will be NO crating area ringside for dogs.
- Soiling the ring is an automatic dismissal.
- Each dog requires an individual entry form for each event/test in which it is entered.
- All entries must be 12 months of age or older on the day of the test.
- Participants will select a 2 hour block for their test/s and will indicate it on the registration form. A block will be limited to 10 entrants to limit gathering. Anyone missing their block will be moved to the next block open. Day of entries will be scheduled into an open block, typically the last one of the day
- Dogs are tested at Owner's sole risk. During the testing, dogs are required to navigate obstacles. Please see the AKC website for testing requirements.
- **Bitches known to be in season may not be brought onto the grounds.**
- All spectators must stand well back from the ring to maintain social distancing and to not act as a distraction To the dog being tested
- Dogs must be on lead or crated unless running or testing.
- A fine will be assessed for any loose dog on the field nocompeting, or an exhibitor caught not picking up after their dog.
- The show grounds are not completely fenced.
- You are responsible for controlling your dog(s) and children. -
- This is a rain-or-shine outdoor event. Please plan accordingly. Please bring your own shade, chairs, and water.

Incomplete entries will not be accepted.

### **AKC Temperament Test (ATT)**

1. Dogs must pass Test #1 & Test #2 to receive the AKC Temperament Title.
2. Choose the block for your test/s at the above mentioned website, submit payment and complete both Test #1 and/or Test #2.
3. Return signed form below to the Trial Secretary at the times indicated above.
4. You will receive a confirmation email once your payment is received and verified.

### **CGC, CGCA**

1. Select the test you wish to take.
2. Select the block you wish to take at the above mentioned website, submit payment and complete the Community Canine Title entry form.
3. Return required forms to the Trial Secretary at the times indicated above.
4. You will receive a confirmation email once your payment is received and verified.
